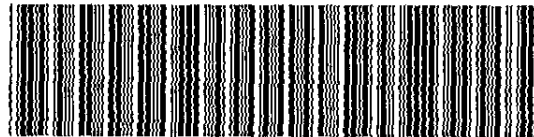

ARTICLE I - NAME

The name of this professional services limited liability company shall be MICHAEL A. GANGLOFF, M.D., P.L.
