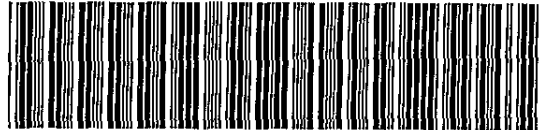

The Company shall be effective October 10, 2003 and shall have perpetual duration.

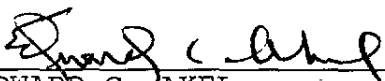
