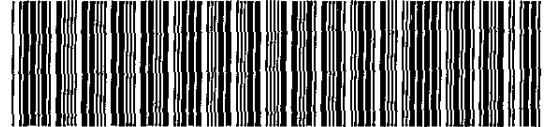

## Articles of Organization for Florida Limited Liability Company

1. The name of the Limited Liability Company:

**BEST'S AQUISITION, LLC**

2. The nature of business to be transacted or the purpose to be promoted or carried out by the limited liability company is as follows:

General Purpose Clause. 
