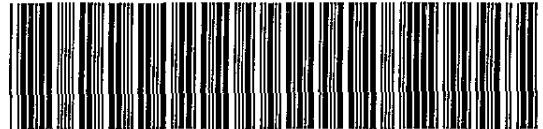



- FIRST:** The date of filing of the articles of organization was October 16, 2003.
