**ARTICLES OF ORGANIZATION OF
STAMPEDE LAND GROUP, L.L.C.**

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is STAMPEDE LAND GROUP, L.L.C.

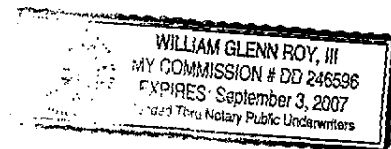
