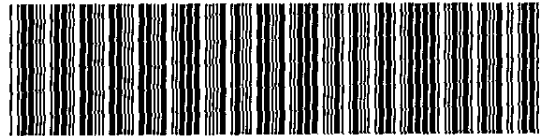

**ARTICLES OF ORGANIZATION
FLORIDA FAMILY RURAL HEALTH CARE, LLC**

The undersigned adopts the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
Name**

The name of the limited liability company, referred to in these Articles as "Company" is FLORIDA FAMILY RURAL HEALTH CARE, LLC.

**ARTICLE II
Duration**

The company shall dissolve on December 31, 2033.

**ARTICLE III
Purpose**

The purpose for which Company is organized is to operate and manage a rural health clinic as well as to transact any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV
Principal Address**

**ARTICLE V
Registered Agent and Office**

**ARTICLE VII
Management**

The company is to be managed by a manager. The initial manager will serve until the first annual meeting of the members. The initial manager is identified as follows:

**ARTICLE VIII
Admission of New Members**

Members shall have the right to admit new members. Additional members may be admitted only on the unanimous written consent of existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. Provided, however, the original member may transfer all or part of their interest to immediate member of their family and these family members shall automatically be admitted as members.


**ARTICLE IX
Remaining Members**

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article VII.




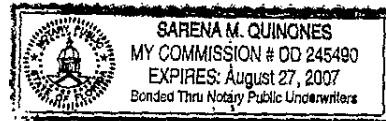


