

ARTICLES OF ORGANIZATION

a Florida Limited Liability Company

A. The name of this Limited Liability: Company is

CINOS ENTERPRISES OF FLORIDA II, L.L.C., (the "Company").

- B. The Articles of Organization of the company were filed with the Florida Secretary of State on July 12, 2002.
