These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I. Name. The name of this limited liability company is SPECIALTEA RESTAURANT SERVICES, L.L.C. ("Company").

ARTICLE II. Duration. The Company shall exist from the date of filing these Articles with the Department of State in perpetuity or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

ARTICLE III. Mailing Address and Street Address. The Company's mailing address is 8815 Conroy-Windermere Road, Suite 402, Orlando, FL 32835. The Company's street address is 8815 Conroy-Windermere Road, Suite 402, Orlando, FL 32835.

ARTICLE IV. Purpose. The purpose for which this limited liability company is organized is any and all lawful business.

ARTICLE VI. Additional Members. Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VII. Termination of Membership. If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.

ARTICLE VIII. Members/Management of the Company. The Company shall initially be managed by the following two members who shall also serve as managers until the first annual meeting of the members or until their successors are elected and qualify:

Thereafter, the Company shall be managed by two managers who shall

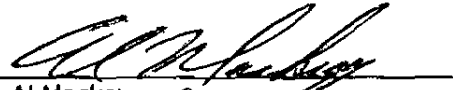
