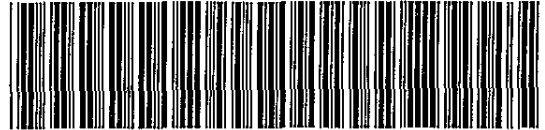



Profits and losses of this limited liability company shall be distributed to each member in proportion to his or her respective ownership interest in TRES BELLE, L.L.C.


