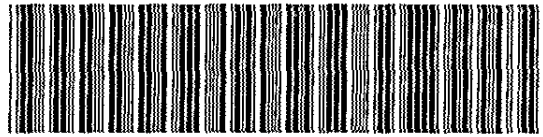





CONTINUATION OF BUSINESS


