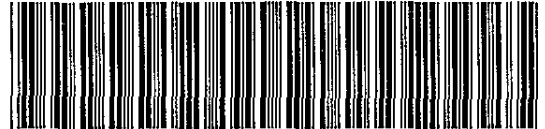

**ARTICLES OF ORGANIZATION
OF
UPON THE HILL MUSIC, L.L.C.**

ARTICLE I

The name of the company is: **UPON THE HILL MUSIC, L.L.C.**

ARTICLE II

The purpose of this company is to engage in any lawful act or activity for which limited liability companies may be organized under the Florida Limited Liability Act, FL Stat., Ch.608.

ARTICLE III

ARTICLE IV

This Article shall neither eliminate or limit the liability of a Manager for any act or omission occurring prior to the adoption of this article.






