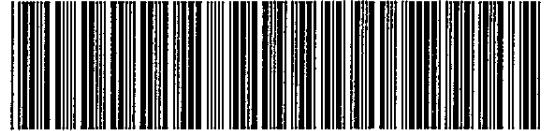




**ARTICLE III
