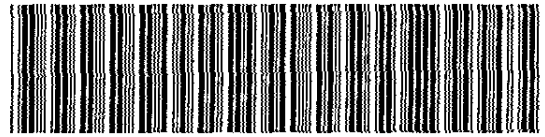

ARTICLES OF ORGANIZATION
OF
SOUTH MOON RANCH, L.L.C.

ARTICLE I.

PREAMBLE; FORMATION

The undersigned, TRACY L. HOWELL, does hereby form a Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, titled as the "Florida Limited Liability Company Act," as hereinafter set forth.

ARTICLE II.

NAME; PLACE OF BUSINESS; AND REGISTERED AGENT

2.1 Name. The name of this Limited Liability Company shall be SOUTH MOON RANCH, L.L.C.

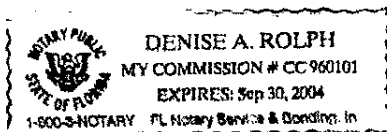
