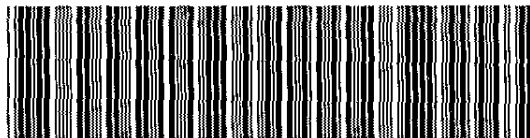

All debts, obligations, and liabilities of the Company have been paid or discharged.


**ARTICLE VI**
