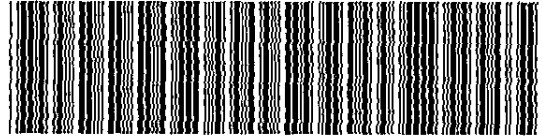

**ARTICLE I -- NAME**

The name and street address of the registered agent of the company in the state of Florida is 7220 Mystic Way, Port St. Lucie, Florida 34986.


**ARTICLE V -- MANAGEMENT**
