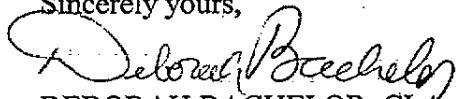

Articles of Organization of TOMYN/LONGCOY, LLC

1. **Name.** The name of this limited liability company is TOMYN/LONGCOY, LLC(the "Company").
2. **Duration.** The company shall exist from the date of signing of these Articles of Organization with the Department of State until the earlier of 30 years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the law of Florida.
4. **Registered Agent and Office.** The name of the initial registered agent of the Company is Rilla Tomy. The street address of the initial registered agent of the Company is 2463 Andre Court, Ocoee, Florida 34761.
5. **Place of Business.** The Company's place of business in 6 S. Bluford Avenue, Ocoee, Florida 3461.
6. **Contributions to the Company.** The total amount of cash initially contributed to the Company by the members is \$75,000.00. No additional contributions have been agreed upon.
7. **Additional Members.** Additional members to the Company may be admitted, but only upon the unanimous consent of all current members.
8. **Termination of Membership.** Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.
9. **Management of the Company.** The management of the Company is reserved to its members. The Company shall be managed in accordance with the regulations and operating agreement adopted by the members. The names and addresses of the members are:

10. **Regulations.** The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

11. **Transfer of Interest.** No member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

12. **Certificated Interests.** The members' interests in the Company shall be evidenced by certificates.

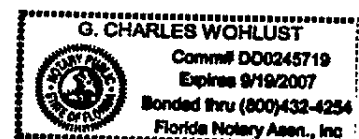

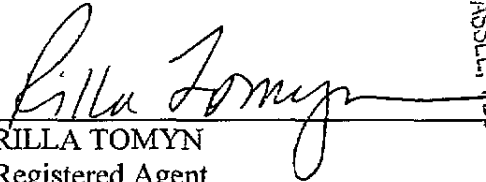
