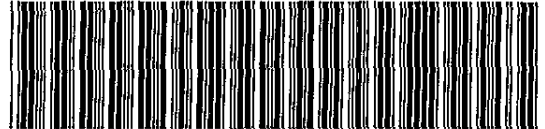





6. **Management**: The Company is to be managed by a manager or managers and is therefore a manager-managed company.


