IN WITNESS WHEREOF, the undersigned Members of the Company have executed these Articles of Dissolution as of the 15th day of November, 2005.

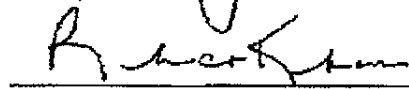
