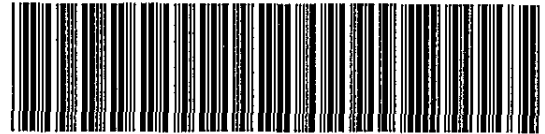



**Fifth:** The duration of the Limited Liability Company shall be perpetual.



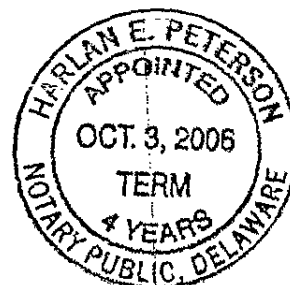
