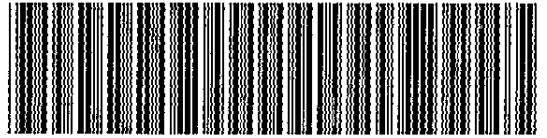

The undersigned-subscribing Members to these Articles of Organization hereby form a Limited Liability Company under the laws of the State of Florida.

**ARTICLE I  
NAME**

The name of this Limited Liability Company is: T&T, LLC

**ARTICLE II  
DURATION AND COMMENCEMENT OF EXISTENCE**

The existence of the Limited Liability Company shall commence upon the date of execution hereof. The Limited Liability Company shall exist in perpetuity unless sooner terminated as provided herein.

**ARTICLE III  
PURPOSE**

This Limited Liability Company is organized for the purposes of transacting any and all lawful business authorized for Limited Liability Companies organized in Florida.

**ARTICLE IV  
ADDRESS**

#### **ARTICLE VI CAPITAL**

The minimum capital of the Limited Liability Company is Two Thousand and No/100ths Dollars (\$2,000.00) and shall be paid in cash or other property. Additional contributions may be required in accordance with the terms of the Operating Agreement of T&T, LLC.

#### **ARTICLE VII ADMISSION OF NEW MEMBERS**

The admission of new Members shall be solely by majority vote (in interest) of the existing members.

#### **ARTICLE VIII DISSOLUTION - WINDING UP - LIQUIDATION**

A. **Dissolution.** Subject to the terms of Subsection B below, the Limited Liability Company shall be dissolved on the happening of any of the following events:

1. Withdrawal (if allowed by the Operating Agreement of the Limited Liability Company), retirement, death, or bankruptcy of any Member.
2. Dissolution of any Member who is an entity.

3. Unanimous written agreement of the Members.

B. **Right to Continue Business.** Notwithstanding Subsection A above, the non-terminated Members ("Remaining Members") of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company, despite the occurrence of any event which terminates the continued membership of a Member in the Limited Liability Company. The exercise of this right to continue shall be by written notice by any one or more of the Remaining Members (representing at least a majority of the interests in the Limited Liability Company) to the other Remaining Members within thirty (30) days of any event described in Subsection A. of this Article. This Subsection B shall not, however, allow for continuation of the Limited Liability Company if the number of Members at any time is less than one (1).

**ARTICLE IX
