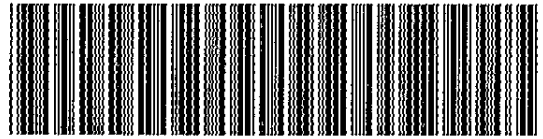


1. Article I of the Articles of Organization of **VIERA VENTURES, LLC** is hereby amended to read:
