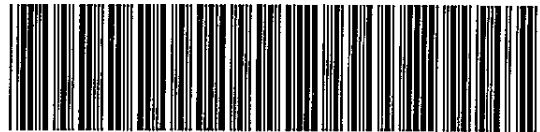

The name of the limited liability company shall be MILLER CONSULTING GROUP OF NAPLES, LLC.


ARTICLE 2: PURPOSE

The company may admit additional members at any time and in any manner by the unanimous written consent of the members.


ARTICLE 10: AMENDMENT
