ARTICLES OF ORGANIZATION OF LA PROMOTIONS, LLC

The undersigned persons, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

ARTICLE I

The effective date of this Company shall be November 1, 2003 (which date is not more than five business days from the actual filing of these Articles of Organization with the Secretary of the State of Florida).


