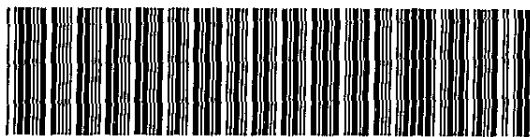

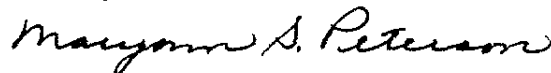

ARTICLE 1: NAME

The name of the limited liability company shall be Total Process Solutions, LLC (the "Company").

ARTICLE 2: PURPOSE

The Company may engage in any lawful business.

ARTICLE 3: RESIDENT AGENT

The name and street address of the resident agent is Andrew Helgesen, 11380 Prosperity Farms Road, Suite 201, Palm Beach Gardens, FL 33410.

ARTICLE 4: PRINCIPAL OFFICE

The Company will be managed by one or more managers.

ARTICLE 6: DURATION

The Company shall exist for 25 years from the date of organization.

The Company may admit any additional members upon the member becoming a party to the operating agreement.

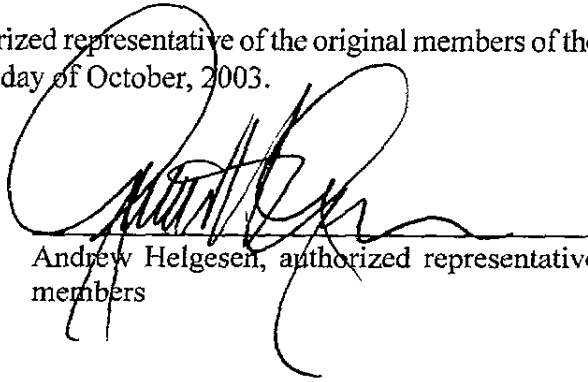
ARTICLE 10: AMENDMENT
