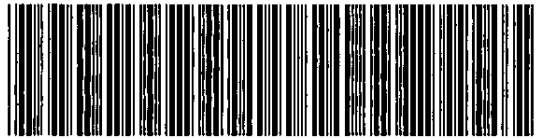

**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION
OF SCHWENN MECHANICAL SERVICES, L.L.C.**

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Florida company hereby adopts the following Articles of Amendment to its Articles of Organization:

Article I - Name and Date of Filing

The name of the company is SCHWENN MECHANICAL SERVICES, L.L.C. (hereinafter referred to as the "Company"). The Articles of Organization of Company were originally filed on November 4, 2003 under Florida document number L03000042651.

Article II - Adoption and Text of Amendments
