**ARTICLES OF ORGANIZATION

**1. NAME.**



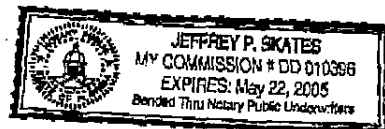


