I already paid the late fee unknowingly that there was a waiver option that I could have used before paying the fee. I work as a traveling Ultrasound technician. Part of the time I employ myself directly to Hospitals and other medical facilities that needing temporary ultrasound staffing, and if I am not able to find a facility for temporary employment on my own I will use an agency.

Before I started traveling I had my own business performing ultrasounds in doctors offices for approximately for 3 years. But a recent bad turn in economic factors forced me to go on the road and seek temporary employment as I stated above. I just took my first assignment in some 4 years, in the beginning of March this year. The assignment ended July 18 th. I had extreme difficulty receiving my mail. I initially filled the paper work at the post office to have my mail forwarded to my new address in Beaufort, South Carolina were my assignment new existed. I received confirmation of the post office and they continued to forward my mail.

Actually, my neighbor across the street noticed that I was still getting mail delivered to my house since he was watching it for me. So he told me what was happening and started to mail the residual mail to me. But, catching that problem was not the end of the problems that I faced. The post office was also sending me other persons mail besides mine; and, others where not getting delivered. So I called the post office in Lehigh Acres from Beaufort and told them of the situation and they were holding mail because the carrier wasn't sure how to deliver them. They (the post office) said they would resend the mail but other letters I did not receive were lost. I am not sure how much mail I have not received but I do know It was quite a bit. I didn't think it was going to cause much of a problem for me since I do all my banking online along with bill paying. So the majority of mail I get is junk or copies of bills that I already have a record for online.

Obviously, you can see how this caught me off guard and from know on I was wondering if you could send me an email stating the timing and payment schedule. Hopefully this will resolves this problem reoccurring in the future. Nevertheless, I am still being forced economically to make a living on the road. I appreciate your understanding in my situation.
