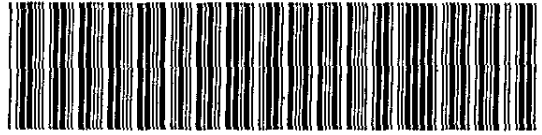



**ARTICLES ORGANIZATION FOR FLORIDA LIMITED  
LIABILITY COMPANY**

**ARTICLES I – NAME:**

The name of the Limited Liability Company is Professional Mobil Detailing LLC.

The period of duration for the Limited Liability Company shall be perpetual.


**ARTICLES IV – Management:**

As used herein, the term “improper personal benefit” does not include a manager’s reasonable compensation or other reasonable incidental benefit for or on account of his service as manager, employee, independent contractor, attorney or consultant of the limited liability company. No amendment or repeal of this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
