



**ARTICLES OF ORGANIZATION**  
**OF**  
**M.L.M.X. ENTERPRISES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **M.L.M.X. ENTERPRISES, L.L.C.** ("Company"). The principal place of business of the Company and mailing address of the Company in Florida shall be 5281 Oxford Crest Drive, Jacksonville, Florida, 32258.

**ARTICLE II - DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

**ARTICLE III - PURPOSES AND POWERS**

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE IV - REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the State of Florida is J. MICHAEL FANT, 5281 Oxford Crest Drive, Jacksonville, Florida, 32258.

## ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the written consent of the member of the Company and upon such terms and conditions as shall be determined by the member. The member may transfer his interest in the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company, if any, other than the member proposing to dispose of his, her or its interest, approves of the proposed transfer by unanimous written consent.


## ARTICLE VI - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members.

## ARTICLE VII - MANAGEMENT

The Company shall be managed by one or more managers and is, therefore, a manager - managed company.
