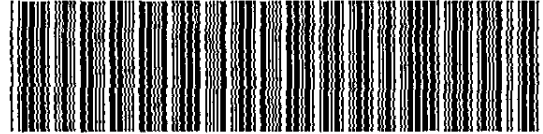

The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Organization, and does hereby agree and certify as follows:

ARTICLE ONE
NAME

The name of this Limited Liability Company shall be **ARAGON, LLC** (the "Company").

ARTICLE TWO
PRINCIPAL OFFICE AND MAILING ADDRESS

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force and effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.
