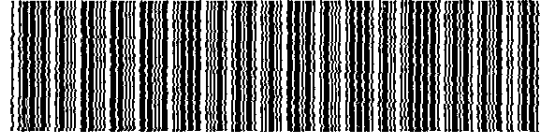

ARTICLE I
