**ARTICLES OF ORGANIZATION
OF
CONSTANT THREAT, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, sets forth the following:

ARTICLE I - NAME

The name of this limited liability company is **CONSTANT THREAT, LLC** (the "Company").

The Company is to be managed by a manager or managers, and is therefore a manager-managed limited liability company. The initial Manager of the Company is HUBERT A. LAIRD.
