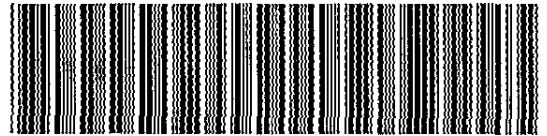

ARTICLE IV - MANAGEMENT






