

ARTICLES OF ORGANIZATION

OF

ImmediaSEA, LLC



Article I - Name

The name of the limited liability company shall be ImmediaSEA, LLC ("Company").

Article II – Address

The mailing address of the principal office is 1921 SW 51st Terrace, Cape Coral, Florida 33914 and street address of the principal office of the Company is 8115 Main Street, Bokeelia, Florida 33922.

Article III - Duration

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. Article VI - Members' Right To Continue Business

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrences of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by majority vote of all the remaining members.

Article VII - Management

The company is to be and shall be managed, in accordance with Operating Agreement for the Company, by a manager, and the name and address of the manager is:

As long as Vincent Formosa is the manager, the manager shall have the power to adopt, alter, amend, or repeal the Operating Agreement. Thereafter, the Operating Agreement may be amended, altered, or repealed in accordance with its terms.

Article VIII - Voting Rights

As long as Vincent Formosa is a member of this Company, he shall be the only member who shall have voting rights, and all other members shall have no voting rights, except as otherwise provided by applicable law. At such time as Vincent Formosa ceases to be a member of this Company, the members shall vote in proportion to their then-current percentages or other interest in the profits of the Company.
