
1. An amendment to the Articles of Organization of Citrus Hills Construction, LLC to change its name to Eboe, LLC; and,

Pursuant to the provisions of Florida Statutes, §608.411, the undersigned limited liability company adopts the following Articles of Amendment of its Articles of Organization:



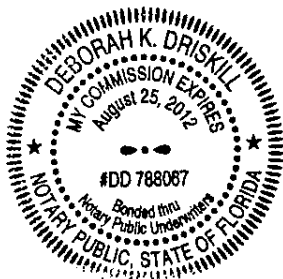


