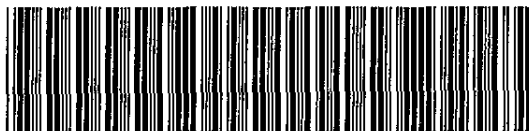

ARTICLE I

ARTICLE VII


