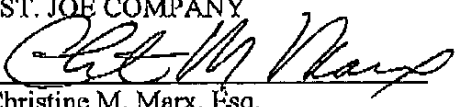
**ARTICLES OF DISSOLUTION

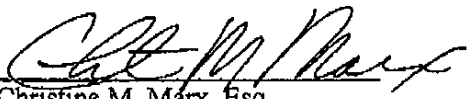
RESOLVED, that the Company shall dissolve its corporate existence effective upon filing Articles of Dissolution with the Florida Secretary of State.
