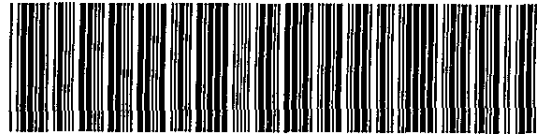




**ARTICLES OF ORGANIZATION

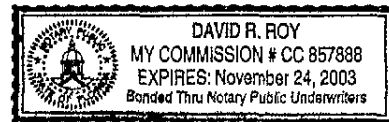


