## ARTICLES OF ORGANIZATION OF

#### PRAETORIAN TRADING, LLC

#### A Florida limited liability company

The undersigned, as an authorized representative of Praetorian Trading, LLC, executes these Articles of Organization for the purpose of forming a limited liability company, pursuant to Section 608.407 of the Florida Limited Liability Company Act (the "Act"), and does hereby make, subscribe and file these Articles of Organization.

#### ARTICLE I -- NAME

The name of this limited liability company (the "Company") is Practorian Trading, LLC.

#### ARTICLE II - ADDRESS

#### ARTICLE VIL - MANAGEMENT

The Company shall be managed by the manager (the "Manager"). The vote of each member shall be in proportion to the Participation of the member unless otherwise provided in the Operating Agreement.
