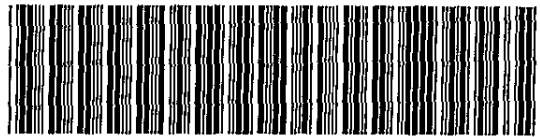



**First:** The name of the limited liability company is: UNIVERSAL IMPACT LLC

**Second:** The mailing address and street address of the principal office of the Limited Liability Company is 1455 Tallevast Road, Suite #L8319, Sarasota, Florida 34243.


**Fourth:** The initial member shall manage the LLC, and shall have authority to take all necessary and proper actions to conduct the business of the LLC. Anyone authorized by the initial member may take any authorized action on behalf of the LLC. The initial member may delegate the management of the LLC to Operating Manager with the full powers to operate and bind the undertaking subjected to the terms and conditions of the Operating Agreement. The initial single member to form the limited liability company shall be: **Coddan Secretary Service Limited, P.O. Box 674, Road Town, Tortola, British Virgin Islands.**

**Fifth:** The members of the limited liability company shall divide the equity of the undertaking in 1, 000 units, to be called "shares", with each individual share having No Stated Par Value. Be it further noted that each share certificate shall state the total number of shares authorized and shall only be valid if signed by the Members and sealed with the company seal. Be it further noted that the Articles of Organization may be amendment from time to time.

**Sixth:** The limited liability company shall exist for the period of thirty (30) years from the date the Secretary of State issue these Articles of Organization.
