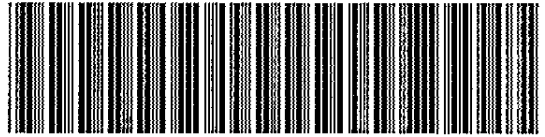

**ARTICLES OF ORGANIZATION
OF

The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME**

The name of the limited liability company shall be **DESIGNERS' COLLECTIBLES, LLC**, a Florida limited liability company (the "Company").

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The mailing address and street address of the principal office of the Company shall be **1136 Dormie Drive, Naples, Florida 34108**.

**ARTICLE III
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered agent of the Company is **4001 Tamiami Trail North, Suite 300, Naples, Florida 34103** and the name of the initial registered agent at such address is **Kevin G. Coleman, Esq.**

**ARTICLE IV
EFFECTIVE DATE**

The Company's effective date of existence shall begin on the date of filing of these Articles.

**ARTICLE V
DURATION**

The Company's duration shall be perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as agreed to by such remaining Members.

**ARTICLE VI
INITIAL MANAGERS**

The Company will be managed by one or more managers, who shall be designated, appointed or elected by the members. The initial number of managers of the Company shall be one (1). The initial manager shall be Evelyn Waldron until such time as the members designate, appoint or elect a successor or substitute manager.
