**ARTICLES OF ORGANIZATION  
OF  
RAK ACCEPTANCE, LLC**

This is to certify that there is hereby organized a limited liability company under and by virtue of the Florida Limited Liability Company Act (Fla. Stat. Ann. §§ 608.401-608.705 (West 2003)) (the "Act").

1. The name of the Company is **RAK ACCEPTANCE, LLC**.
2. The mailing and street address of the principal office of the Company is 3550 Gateway Drive, Pompano Beach, FL 33069.
3. The name and street address of the Company's initial registered agent for service of process in the State of Florida shall be W. Bradley Monroe, Esquire, at 239 E. Virginia Street, Tallahassee, FL 32301. The Company certifies that it shall have and continuously maintain in the State of Florida a registered office and agent.
4. Simultaneously with the filing of these Articles of Organization, the initial registered agent represents that it accepts its appointment as registered agent, and certifies that it is familiar with, and accepts, the obligations of its position as provided under the Act.
5. The purposes for which the Company is organized are: To engage in any activity within the purposes for which companies may be organized under the Act.

Except as otherwise required by Sections 608.4225 and 608.4227 of the Act (both of which are effective and in force on the date on which these Articles of Organization are signed), the manager of the Company shall not be personally liable to the Company or its members for damages for breach of any duty owed to the Company or its members.
