ARTICLES OF ORGANIZATION
OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is: **CONSTRUCTION WINDSCREEN DESIGNS, L.C.**

ARTICLE II

Address of Place of Business.

The street address and mailing address of the principal office in Florida for the Limited Liability Company is: 1121 South Military Trail, #111, Deerfield Beach, FL 33447.

ARTICLE III

Purpose

The Limited Liability Company is organized for the purpose of transacting any and all lawful business for which limited liability companies may be formed under Chapter 608 of the Florida Statutes. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall not be continued and the Limited Liability Company shall be dissolved unless there is obtained the consent of all the remaining members of the Limited Liability Company.
