**ARTICLES OF ORGANIZATION
OF**

LAXVEN VENTURES, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be LaxVen Ventures, L.L.C.

ARTICLE II -- ADDRESS

The mailing address of the principal office is P.O. Box 4281, Ocala, FL 34478 and the street address of the principal office of the limited liability company is 2901 SW 41st St., #811, Ocala, FL 34474.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

ARTICLE VIV -- MANAGEMENT

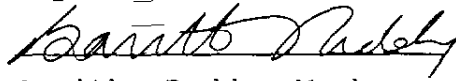
