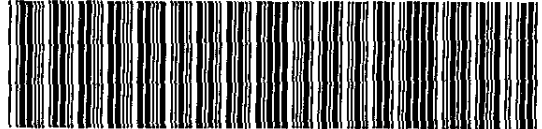




ARTICLE V
