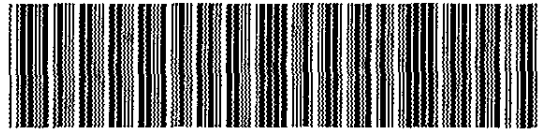

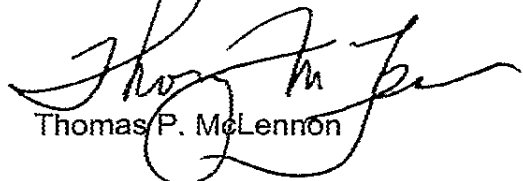

**ARTICLE IV — Management:**

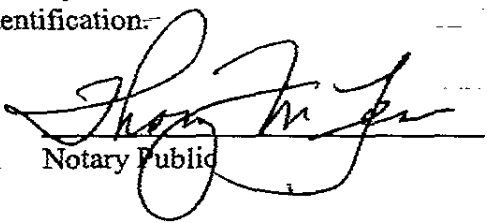

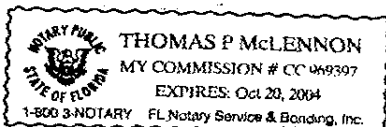

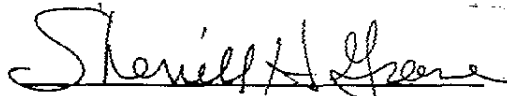
