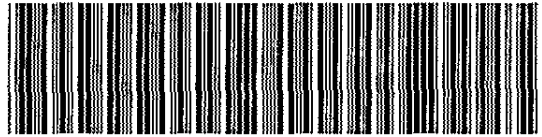



**ARTICLES OF ORGANIZATION**

1. Name. The name of the Limited Liability Company is The Party Line Tent and Party, LLC (the Company).
