ARTICLES OF ORGANIZATION
THE PARTY LINE TENT AND PARTY, LLC
A FLORIDA LIMITED LIABILITY COMPANY

1. Name. The name of the Limited Liability Company is The Party Line Tent and Party, LLC (the Company).
2. Purpose. The purpose of this Company shall include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
