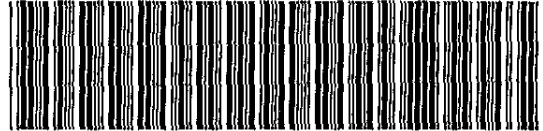

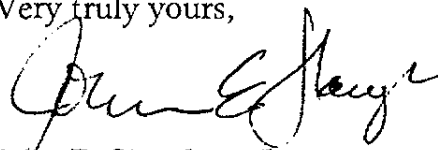

OF
CHANDLER & CHASE ENTERPRISES, LLC**

The undersigned, acting as an Organizer of a limited liability company under the Florida Limited Liability Company Act, as defined in Chapter 608 of the Florida Statutes, adopts the following Articles of Organization.

**I.
NAME**
