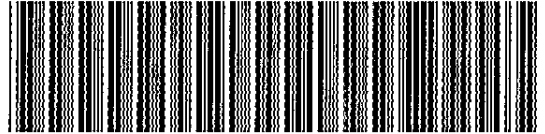



The name of this Limited Liability Company is Bonny Ison Painting, LLC.


ARTICLE II--ADDRESS
